This new curriculum was implemented at the beginning of academic year 2022-2023. [WR] Our new curriculum is already consistent with University and Faculty vision and mission. We also defined the 3 graduate profiles for our graduates, they are Technical Engineer and manager, Researcher/Academics and entrepreneurs, which aligns with IE vision and mission. [WR] This graduate profile was also being benchmarks already with others private university which we consider is adequate to be as a benchmark study program as well. [WR] To achieve the defined graduate profile, this curriculum is also characterized into 7 PLOs, which also aligned with MBKM and BKSTI policy. [WR] In summary, our degree plans designed for 8 semesters with total of 145 credits (semester 1 – 4 consist of 77 credits and Semester 5 – 8 consist of 68 credits).
