	Change of SU Senate Bylaws The University Executive has approved and endorsed the new SU Senate Bylaws as proposed by the Senate Members based on Senate Meeting on October 6th, 2023. This decision was then approved by all SU Senate Members through Circular Resolution No. 001/CR-UE/SU/Senate/II/2024. The changes of the Senate Bylaws are: • Change all word "institutes" to "units" • Delete the definition of "Head of Institutes" • Article 8, Point 1: Change the number of representative members from Academic Units to 1 member. • Article 8, Point 7: Change the number of qualified representative members in Academic Unit to be appointed by default if there is only 1 member. • Article 9, Point 4:
