## **University Executive Meeting & Circular Resolutions**

The University Executive (UE) of Sampoerna University held its meeting on October 3<sup>rd</sup>, October 31<sup>st</sup>, November 14<sup>th</sup>, 2024 and Circular Resolutions dated October 15<sup>th</sup>, November 21<sup>st</sup>, December 18<sup>th</sup> and December 27<sup>th</sup>. Oct 3	Policy for Non-Degree Seeking Students Enrollment This policy defines the status of non-degree seeking (NDS) students at SU and all relevant rights and responsibilities which are conferred to them. The establishment of an NDS policy will allow for non-traditional student enrollment on a limited, targeted basis, including professional certificate seekers, high school students, MBKB participants, and others who need a finite series of classes for specific purposes.
